AFFIDAVIT FOR ELECTRONIC DISPLAY SIGNS

I (owner), _____, to abide by the City of Branson sign regulations and I, understand the terms of these regulations, including, but not limited to, the following:

1. There shall be no off-premises advertising content displayed on the sign.
2. The names of the on-premises businesses that will be advertising on this sign are:

3. The light from any illuminated sign shall be so shaded, shielded, or directed so that the light intensity or brightness shall not be projected over the property lines into a residential zone except by indirect reflection. Neither the direct or indirect light from a primary light source of a sign shall create a traffic hazard to operators of motor vehicles or pedestrians on public thoroughfares. Branson Municipal Code Section 70-8(3).
4. No sign is allowed with flashing or rotating lights which would interfere with the safe passage of vehicular traffic, and no sign shall be allowed to simulate an emergency vehicle. Branson Municipal Code Section 70-8(3).
5. The intensity of the sign shall be automatically regulated such that the dusk-to-dawn brightness shall be 50% of the daytime intensity.
6. The Director of Planning and Development, or a duly authorized representative, shall identify and shall order the disconnection or removal of any signs, at cost to the owner, that has been erected or maintained in violation of the Branson Municipal Sign Code Section 70-6(9) and 70-6(10).
