

ELMO & ROSALEA MARRS DOG PARK



Rules & Regulations

1. Daily hours of operation shall be from sunrise until sunset.
2. A membership must be purchased with the Branson Parks Department prior to entry in the Elmo & Rosalea Marris Memorial Dog Park ("Dog Park" hereafter).
3. Dogs must be current on all vaccinations and must have a current rabies tag.
4. Children under the age of 8 are not allowed in the Dog Park. No one under the age of 18 is allowed unless accompanied by an adult. Owners are legally responsible for the actions of their dogs.
5. Do not put your Dog Park privileges or your pet at risk by allowing entrance to unauthorized persons and pets. Close gates firmly after entering or leaving the Dog Park.
6. A maximum of two (2) dogs are allowed per handler.
7. Keep your dog(s) on leash until you are inside the fenced off-leash designated area. Leaving dogs unattended is prohibited. Handlers must monitor and control their dog(s) at all times. While inside the off-leash area, you must keep one leash per dog with you at all times.
8. Spike or pinch collars are not allowed to be used while in the Dog Park. Only flat collars and/or a harness may be used.
9. If your dog digs, it must be stopped and the hole filled in by its owner/handler.
10. "Scoop your poop." Owners must clean up after their dogs. Failure will result in revocation of Dog Park membership. (Code 1988, § 280.090; Code 1996, § 275.220(A); Ord. No. 90-30, § 9, 8-13-1990)
11. The following dogs will not be permitted inside the Park:
 - a. Puppies under the age of four (4) months
 - b. Dogs in heat
 - c. Sick or Injured Dogs
 - d. Aggressive Dogs
12. No food or dog treats are allowed in the Dog Park. Water is provided inside the off-leash area for dogs only.
13. No animals other than dogs may be brought into the off-leash area.
14. Strollers, carriages, bicycles, skate boards, scooters, skates, roller blades, sport activities, or motorized vehicles (unless used for assistance device) are not allowed inside the Dog Park.
15. Professional dog trainers may not use the facilities in the conduct of their business.
16. No smoking, tobacco, or alcohol shall be permitted inside the Park.
17. Failure to follow rules and regulations will result in removal from the Dog Park and may result in revocation of Dog Park membership. No refunds will be given.
